

2024/2025 Nomination Criteria Canadian Alpine Ski Team

Effective October 15, 2023

1. INTRODUCTION

- 1.1. The Nomination Criteria outline the process applicable to all Athletes considered for nomination to the Canadian Alpine Ski Team.
- 1.2. The Nomination Criteria shall be interpreted and applied in accordance with the principles of procedural fairness and natural justice.
- 1.3. The Alpine, High-Performance Director is responsible for developing and the ACA PerformanceCommittee is responsible for approving these Nomination Criteria, which set out the process and procedures that will be applied to nominate eligible athletes to the 2024-2025 Canadian Alpine Ski Team.

2. PERFORMANCE OBJECTIVES

2.1. This Nomination Criteria will be applied in accordance with ACA's performance objective, which is to be a world leading ski racing nation and achieve a Top 5 in the medal ranks at OWG/WSC (2-3 podiums). To achieve this performance objective, athletes who have demonstrated evidence of podium potential at the WSC and for the 2026 OWG will be selected in priority, and the next level of priority will be to select athletes who have demonstrated evidence of podium potential at the 2030 OWG.

3. TEAM LIMITATIONS

- 3.1. Notwithstanding anything contained in these Nomination Guidelines, ACA will determine the number of Athletes that can be nominated to CAST based on available financial resources.
- 3.2. As a condition of being nominated to CAST, ACA may require Athletes to make a financial contribution to offset program costs.

4. ELIGIBILITY

- 4.1. In order to be eligible for nomination to CAST, an Athlete must:
 - I. Satisfy all FIS citizen requirements to represent Canada;
 - II. Satisfy the nomination qualification criteria under Section 6 during the Competitive Season;
 - III. Be a registered participant of ACA and a Member in Good Standing;
 - IV. Meet FIS medical requirements in accordance with Article 221: Medical Services, Examinations and Doping of the International Ski Committee Rules (ICR):
 - V. Not be subject to a provisional suspension or period of ineligibility for any doping-related offence or any disciplinary offence; and

Athletes who have previously declined to be a member of CAST and have continued their ski racing career with Independent Status shall not automatically benamed to CAST for 2024-25 regardless of results achieved during the competition season. 5. CRITERIA

The following criteria will be used in order of categories from Automatic Nomination (AN), Current Olympic Quad (COQ) and finally NextGen Olympic Quad (NOQ).

Within each category of nomination, nomination identification will progress from the first line of criteria within the category down throughout each following line of criteria. Ties will be broken by WCSL/WC rank and, if a tie still exists, by the FIS WR in the same discipline. Age markers have been establishedbased on Olympic Podium Pathway metrics.

In its discretion, ACA may make additional discretionary nominations to reach a desired team size according to financial considerations.

5.2 Current Olympic Quad Criteria (COQ) - (**6.2 Year of Birth for 2024/2025** Team Nomination: 1998 to 2008 for Women and 1996 to 2008 for Men)

- Top 25 WCSL/WC standings (SL, GS, SG or DH); or 1.
- Top 30 WCSL/WC standings in 2 disciplines (SL, GS, SG or DH); or 2.
- 3. Within the current season an athlete's first career Top 7 performance in either the WSC or OWG (SL, GS, SG or DH)

- 4. World Junior Championship Podium (SL, GS, SG or DH)

5.4 Discretionary Nominations

If an Athlete does not satisfy the objective performance standards indicated in Sections 6.1-6.3, the CAST Alpine Staff shall have the sole discretion to recommend or not recommend any Athlete for nomination to the CAST teams under Coaches Discretion.

Athletes may be nominated to the CAST under Coaches Discretion considering the following factors/circumstances:

- History of hitting significant performance markers at:
 - **Olympics and World Championships** 0
 - World Cup 0
 - Europa Cup 0
 - World Cup Start List/World Standings Rank, World FIS Rank 0



- Ideal functional size of training and competition groups
- Attitude, commitment, and positive contribution to the athlete development system and team culture

Notwithstanding the aforementioned, an Athlete may be nominated to the CAST under Coaches Discretion for season-ending health-related reasons such as an injury, illness or pregnancy sustained in the previous 24 months that has prevented the Athlete from achieving the criteria in Sections 5.1-5.3 of these Nomination Criteria.

In order to receive a discretionary nomination for season-ending health-related reasons, the following factors will be assessed during the Coaches Nomination Meeting and by the TSAC:

- I. Whether the Athlete has achieved results deemed by the CAST Alpine Staff to be comparable to nomination criteria prior to their change in health-related status;
- II. The Athlete has committed to a return to snow program and is expected to return to full capabilities and either meet or exceed other nominated athletes; and
- III. The Athlete has a doctor's certificate attesting that they are likely to achieve a full recovery and the indication of the estimated recovery period
- 5.5 Discretionary Nomination Conditions
- a. An Athlete cannot receive a Coaches Discretion Nomination more than three times during their tenure with the CAST, and for no more than two consecutive seasons. However, any previous CAST nomination under Coaches Discretion due to a season-ending health-related reason will not count toward the total number of a years that an Athlete can be nominated to the CAST under Coaches Discretion.
- b. Any nomination based on Coaches Discretion may require the Athlete to satisfy individualized performance and/or fitness criteria throughout the Competitive Season in order to remain on the CAST teams. There is an expectation that team athletes will demonstrate forward progress towards performance criteria. Athletes will be evaluated individually on a case by-case basis yearly post season, to clearly evaluate forward progress, future performance goals and determination of team status
- c. Any nomination based on Coaches Discretion may be subject to Pay-to-Play or complete selffunded terms.
- d. The CAST Alpine Staff shall complete the individual evaluations and reserves the right to notnominate an Athlete pursuant to Coaches Discretion.
- e. Proposed discretionary selections will be reviewed and discussed during the Coaches Nomination Meeting. An explanation of the discretionary selections proposed during the Coaches Nomination Meeting will be provided to the ACA Team Selection Advisory Committee (TSAC) for review.

6. NOMINATION PROCESS

- 6.1. The Athletic Directors for the PTSO of each province, or any CAST Alpine Staff, may identify an Athlete for nomination by providing the following materials to the High-Performance Director, Alpine prior to Coaches Nomination Meeting which will be announced one month in advance:
 - I. In the case of past injury status: Medical history for the previous three seasons;
 - II. Athlete tracking information
 - III. Fitness testing results from the previous three seasons; and
 - IV. Season End IPP form if available



- 6.2. All CAST Athletes shall be automatically considered for nomination to CAST. CAST Athletes considered for Coaches Discretion shall be notified and have a reasonable opportunity to provide written comments prior to the Coaches Nomination Meeting.
- 6.3. The CAST Alpine Staff shall meet as a Coaches Nomination Meeting and shall make recommendations for nomination to the CAST teams. ACA will advise the TSAC and CAST Alpine Staff of the TSAC Nomination Meeting date at minimum, 14 days prior to the selected date.
- 6.4. All recommendations for nomination shall be provided to the TSAC at least two (2) days in advance of the TSAC Nomination meeting. This will include a complete written explanation of all Athletes considered for discretion. An athletes Discretionary Nomination Package will be provided for athletes being nominated through discretion and will include without limitation, the applicable previous results considered, any specific information applicable and any other relevant comments, finding or conclusions arising from the Coaches Nomination Meeting.
- 6.5. At the TSAC Nomination Meeting, the TSAC shall review the CAST Alpine Staff recommendations and determine if the Nomination Criteria have been applied toeach Athlete under consideration. If the TSAC is satisfied that the Nomination Criteria have been properly applied, then they shall accept the CAST Alpine Staff nominations.
- 6.6. In the event that TSAC determines that the Nomination Criteria have not been properly applied to any Athlete, the TSAC shall advise the CAST Alpine Staff in writing of their findings and shall require the CAST Alpine Staff to conduct a second assessment of the Athlete.
- 6.7. The CAST Alpine Staff shall provide the TSAC with minutes of the second assessment, including applicable criteria and previous results relied on, any comments related to their second assessment and their decision for, or against, recommending the Athlete for nomination to CAST. The minutes shall be provided to the TSAC within two (2) days of the second assessment. The TSAC shall not approve a CAST Alpine Staff recommendation of an Athlete to the CAST teams unless they are satisfied that these Nomination Criteria have been properly applied.
- 6.8. Nominations shall be forwarded by the CEO to the BOD for final ratification.
- 6.9. The High-Performance Director, Alpine and the National Team Head Coach, or another designated CAST representative within one week of the BOD ratification shall notify, by telephone, teleconference or in person, those Athletes nominated to CAST.
- 6.10. Those athletes considered but not nominated to the CAST will be contacted by the High-Performance Director, Alpine or his/her designee, along with another CAST representative in person or via teleconference, so that the Athlete receives communication most effectively and personally. Athletes previously named to CAST who are retiring or not re-nominated are entitled to an exit interview at the discretion of the Athlete andwill receive offboarding information and guidance.
- 6.11. Athletes nominated to CAST who wish to decline their nomination must advise ACA within seven (7) days after notification.



- 6.12. All nominated athletes are subject to a medical consultation with an ACA appointed medical doctor. ACA reserves the right to remove any nominated athlete not deemed fit to race/train in the 2024-2025 season.
- 6.13. Final team status will be determined in May 2024 after CAST planning and budgeting is complete.
- 6.14. After final team status is confirmed, CAST athletes will be required to reach or maintain predetermined individual fitness standard in order to maintain their team status. These standards will be communicated to athletes by early July 2024 after the final team status is confirmed.

7. UNFORESEEN CIRCUMSTANCES & REVISIONS

- 7.1. In situations where unforeseen circumstances do not allow the nomination process to be applied in the manner set out in this policy, the High-Performance Director, Alpine with Performance Committee approval, reserves the right to determine an appropriate course of action.
- 7.2. The High-Performance Director, Alpine, with Performance Committee approval, may exercise discretion to revise this policy prior to the end of the qualifying period with any revisions as may be reasonably necessary to avoid disputes over the interpretation of the Nomination Process. This clause shall not be used to justify changes after a competition or trials which formed part of these Nomination Criteria unless it is related to an unforeseen circumstance. This is toallow for changes to this document that may become necessary due to a typographical error or a lack of clarity in a definition or wording.

8. APPEALS

- 8.1. Any appeal in relation to the CAST nomination process must be brought directly to the SDRCC to be heard pursuant to the Canadian Sport Dispute Resolution Code.
- 8.2. An Athlete who wishes to appeal the team nominations shall, within 3 business days of the release of the public team announcement, file an appeal with the SDRCC.
- 8.3. Appeals will not be accepted past this deadline.
- 8.4. The ACA Board Athlete Representative or the ACA Athlete Council Chair will be an available resource to any athlete pursuing anappeal.

N.B. In the event of a discrepancy between the English and French version of the 2024-2025 Nomination Criteria, ACA will refer to the English version for the purpose of understanding the intended drafting in the French version.

9. **DEFINITIONS**

- 9.1. ACA Alpine Canada Alpin.
- 9.2. Athlete a FIS carded Athlete that is a Canadian resident or citizen as defined in the Citizenship and Immigration Act (Canada).
- 9.3. CAST Canadian Alpine Ski Team.

9.4. CAST Alpine Staff – any one of the following: High Performance Director, Alpine, the discipline Head Coaches or any other coach that is designated as a CAST coach, from time to time, by Alpine Canada Alpin 147 Canada Olympic Road SW Suite 250, Calgary, AB, T3B 6B7 T. 403.777.3200 alpinecanada.org

- 9.5. PTSO Athletic Director Provincial/Territorial Sport Organization Athletic Directors identified by the Vice-President, Domestic Sport Programs and Events.
- 9.6. Performance Committee ACA Board appointed and provides strategic direction and review of ACA's mandates, the scope and quality of ACA programs, athlete experience, and selection criteria.
- 9.7. BOD Board of Directors of Alpine Canada Alpin.
- 9.8. FIS International Ski Federation.
- 9.9. WADA World Anti-Doping Agency.
- 9.10. CCES Canadian Centre for Ethics in Sport.
- 9.11. SDRCC Sport Dispute Resolution Centre of Canada.
- 9.12. Coaches Discretion means the exercise of discretion by the CAST Alpine Staff to nominate or not-nominate, an Athlete to the CAST based on the considerations set out in these Nomination Criteria.
- 9.13. Coaches Nomination Meeting a meeting of the CAST Alpine Staff called for the purpose of making recommendations for nomination to the CAST pursuant to these Nomination Criteria.
- 9.14. Competitive Season all FIS events between July 1, 2023, and April 15, 2024.
- 9.15. WCSL/WC Standings World Cup Start List (WCSL) may apply both the WCSL, and the World Cup Standings based on the list published after the World Cup Finals.
- 9.16. IPP Form the written Individual Performance Plan prepared and submitted by the CAST discipline head coaches that sets out the technical evaluation, performance evaluation and achievement goalsof each Athlete.
- 9.17. Team Selection Advisory Committee (TSAC) a committee constituted by ACA that may include the following representatives: COC representative; Integrated Support Team ("IST") representative; ACA High Performance Director, Alpine and ACA Vice-President, Domestic Sport Programs and Events; ACA Board Athlete representative; Alumni representative; and any other individuals appointed by the TSAC in its discretion.
- 9.18. TSAC Nomination Meeting the annual meeting of the TSAC that occurs at the conclusion of the Coaches Nomination Meeting usually in April 2024, during which the TSAC shall review the recommendations and evaluate the decisions made by the CAST Alpine Staff to ensure that the Nomination Criteria have been applied correctly.
- 9.19. Member In Good Standing A registered participant of ACA or CAST team member who has completed all mandatory items presented by ACA and is adhering to all items outlined within the ACA Code of Conduct and Athlete Agreement.

9.21. Independent Status – An athlete nominated to CAST who has declined CAST nomination and support and therefore choosing to train and compete independently.
